Terms and Conditions for Hire of Equipment and Crew

The acceptance of equipment (see attached list of equipment) by the Client, or his agent, implies acceptance of these terms and conditions.

Quotation, payment terms and cancellation policy

Payment terms shall be as agreed in the quotation.

A down payment of 50% of full rate shall be paid on day of collection.

Cancellation of a booking received by Mediadante after 24 hours or less notice will be charged at 50% of the full rate.

Cancellation of a booking received by Mediadante at 48 hours or less will be charged a booking fee of 20% of the full rate.

Equipment lists

On collection, the Client should check equipment list and actual equipment carefully. Equipment not returned as per the list and in the same condition (ordinary wear and tear excepted) will be deemed lost or damaged. The Client will be charged for the replacement or repair.

We hire out equipment with crew only. We make exceptions to this clause based on professional judgment. When exception is made, it is assumed the Client has sufficient skills to operate hired equipment correctly. It is the responsibility of the Client to ensure the equipment being rented is suitable for the purposes intended.

Collection and return of equipment

Equipment may be collected and returned by prior arrangement during normal office hours of Sunday – Thursday 10 am – 7 pm. Equipment return time is 10:00am the day after final hire day. Additional daily hire charge applies when equipment is not returned to Mediadante by 11:00am.

Collection or return outside of normal office hours will incur additional charges of 200 QAR per hour, charged pro rate at 30 minute intervals.

Condition of equipment

Mediadante will repair or supply replacement of equipment found to be defective or deficient provided the Client returns such equipment to Mediadante. Payment of hire charge during the period in which the equipment is out of service will be suspended by Mediadante.

Title of Equipment

The Client acknowledges that it claims and shall acquire no right in the Title to the Equipment being hired and that Title to the equipment shall be and remain in Mediadante or any party claiming through Mediadante.

Lost or damaged equipment

Mediadante insurance does not cover equipment hired by Clients. Clients may choose to take out their own insurance.

Client is responsible for damage to equipment due to abuse, misuse or negligence by non-Mediadante crew.

Client is responsible for loss or damage to equipment from theft, mysterious disappearance, fire or any other cause.

In accepting liability for the safe keeping of all rented equipment. Client agrees to pay the charges to repair damaged equipment or replace lost equipment including any hire charges incurred by Mediadante whilst equipment is out of use.

Crew

Crew rates are for a 12 hour day including set-up and travel time. Extra hours are charged at 1.5 times the hourly rate.

Crew half day is 5 hours. Extra hours will be charged at the hourly rate up to 7 hours and a full day rate thereafter.

Client will be responsible for providing at least one meal and half hour meal break during a 12 hour day. There is no discounted rate for breaks.
